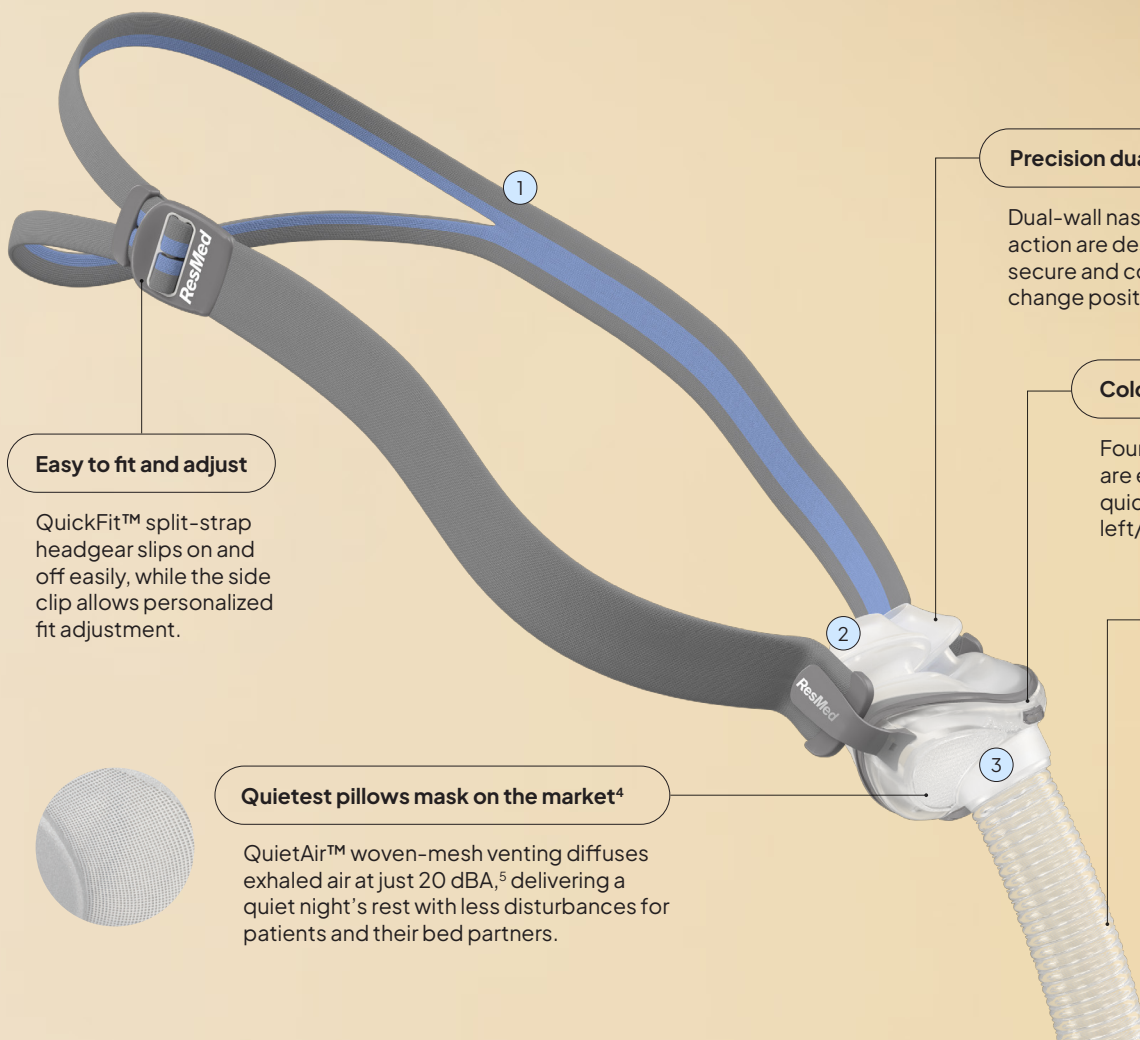

Four pillow sizes (XS, S, M, L) are each color-coded for quick size identification and left/right orientation.

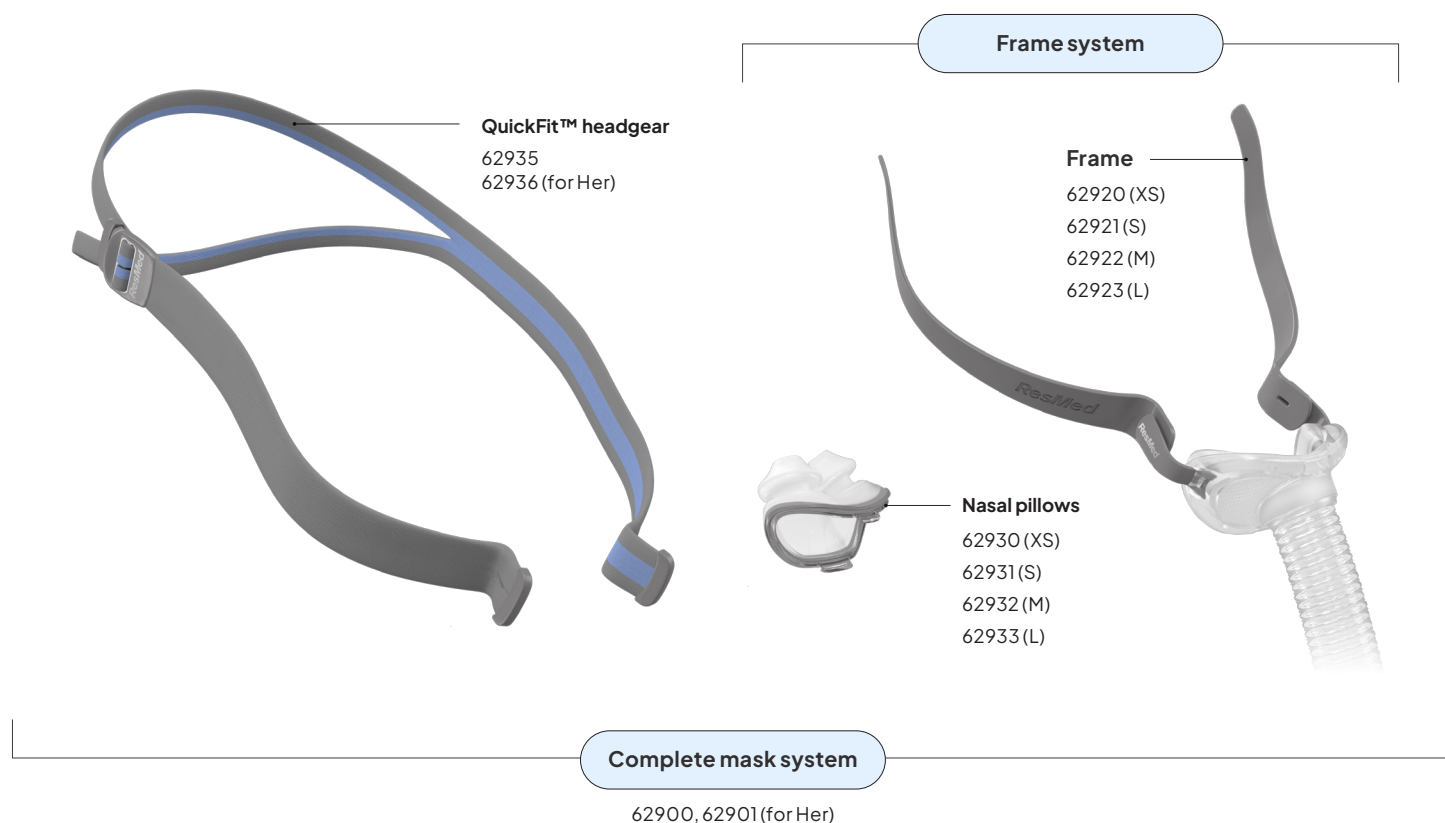
Lightweight flexi-tube

Fitting guide



While holding the pillows away from your nose, make sure the pillow size and left (L) and right (R) indicators are facing towards you.



Guide the nasal pillows into your nostrils. Pull the QuickFit™ headgear over the head by holding the bottom band and stretching it around the back of the head. The top band should sit comfortably on the top of your head.



To achieve a comfortable fit, spread the split bands on the QuickFit™ headgear apart to loosen the mask or draw them closer together to tighten the mask.



Briefly pull the mask away from your face, then place it back. Ensure the nasal pillows fit securely in your nostrils and that both pillows are positioned upright.



To adjust the QuickFit™ headgear, pull the band through the single side-clip until you achieve a comfortable seal. Do not overtighten and readjust as needed over time.



Connect the mask tube to the device — your mask is now ready to use.



For longer hair, we recommend feeding it through the back of the headgear. If tied in a ponytail, it should sit high enough to fit comfortably through the split band on the headgear.

² Data are derived from an analysis of new PAP therapy patients in the United States using AirView™ and myAir™ platforms. Patients were included if myAir™ setup occurred from 7 days before through 14 days after the AirView™ setup date (i.e., –7 to +14 days) and valid mask data were available. Compliance (90-day) was assessed for setups between January 2024 and December 2024. Compliance was defined as PAP use for ≥4 hours per night on ≥70% of nights during any consecutive 30-day period within the first 90 days of therapy, with the AirView™ setup date counted as day 1. Days to compliance represents the number of days from AirView™ setup until the first date the patient achieved compliance. Analysis included the top 45 mask models, representing 99.8% of mask selections among new users in myAir™. Days to compliance (90th percentile) is the number of days from AirView™ setup by which 90% of patients achieved compliance. Overall average = 41.7 days mean across the 45 included mask models; n = 557,021. AirFit P10 = 39 days, n = 65,796.

³ Data are derived from an analysis of U.S. PAP therapy patients using AirView™ and myAir platforms. Patients were included based on registration within ±14 days of AirView setup and valid mask data. Compliance was assessed for 2024 setups (n = 557,021; AirFit™ P10 n = 65,796), and 1-year adherence for 2023 setups (n = 389,270; AirFit™ P10 n = 50,156). Compliance was defined as PAP use for ≥4 hours per night on ≥70% of nights during any consecutive 30-day period within the first 90 days of therapy. AirFit™ P10 demonstrated lower leak rates than the average for pillows masks (median 1.9 vs. 2.2 L/min; 95th percentile 12.0 vs. 12.7 L/min). No statistical significance testing was performed.

⁴ Leading nasal pillows masks selected based on Resmed analysis of U.S. market data as of June 2026. Masks reviewed: F&P Nova Micro, F&P Solo Pillows, Philips DreamWear Pillows, React Health Rio II, and AirFit P10. Comparison based on manufacturer-published user-guide sound power declarations and Resmed objective bench testing comparing AirFit P10 and F&P Nova Micro Pillows under flow-normalised conditions (approx. 33 L/min).
